ARTICLES OF ORGANIZATION OF PATRICK BORDEAUX TRADING L.C.

A CHED The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.s. chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company is Patrick Bordeaux Trading L.C. (the "Company").

ARTICLE II DURATION

The period of the Company's duration shall commence on the date that these Articles of Organization are filed with the Florida Department of State and shall be continued until December 31, 2046, unless the Company is earlier dissolved as provided for by law, by these Articles of Organization or in the regulations of the company.

ARTICLE III MAILING AND STREET ADDRESSES

The mailing address and the street address of the principal office of the Company is c/o Patrick Bordeaux, 2501 Brickel Avenue, Suite 1103, Miami, Florida 33129.

ARTICLE IV NAME AND ADDRESS OF INITIAL REGISTERED AGENT

The name and street address of the initial registered agent of the Company in the State of Florida are Guy Rabideau, Esq., c/o Winthrop, Stimson, Putnam & Roberts, 125 Worth Avenue, Palm Beach, Florida 33480. A statement of the initial registered agent accepting his appointment is attached to these Articles of Organization.

ARTICLE V ADMISSION OF NEW MEMBERS

Members of the Company shall have the right to admit additional members to the Company only with the unanimous written consent of all the members of the Company and only upon such terms and conditions as shall be determined by all of the members.

ARTICLE VI TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of certain other events as more fully provided in the regulations of the Company, unless the business of the Company is continued by the consent of all remaining members of the Company (and provided that there are at least two remaining members).

ARTICLE VII MANAGEMENT

The Company shall be managed by a manager or managers in accordance with the regulations of the Company. Initially, there shall be one (1) manager of the Company (although certain matters, as set forth in the regulations of the Company, shall require the consent of all of the members of the Company). The manager or managers shall be selected by the members as required by Florida law. The manager or managers shall have the responsibilities set forth in the regulations of the Company. The regulations of the Company may also contain any other provisions for the regulation and management of the affairs of the Company not inconsistent with law or with these Articles of Organization.
