The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization for such company:

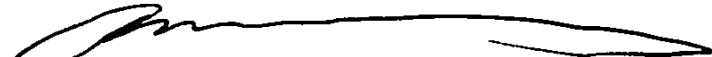

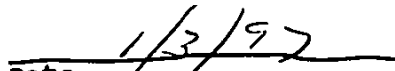
