Business Plan

Chemical Dependencies L.C. is intended to operate as a service type company in the pool service and allied health industries.

Initial income will be generated from pool services (and related types of service). Subsequent income may be generated from research, development, evaluation, teaching or tutoring, technical writing, workshops or seminars, the sale of publications (which may include tapes, cartoons, bumper stickers and other media) or products in the fields of nutrition, fitness and health, any of which may contribute to personal healing.

The foregoing purposes, objectives and activities will be interpreted as examples only and not as limitations, and nothing herein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for the furtherance of the corporate purposes, objectives and activities detailed above.

ARTICLE V - Admission of Additional Members:

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:

In the event of the death or total disability of one member, the remaining member may nominate a new member to replace the member who has died or has been disabled.

ARTICLE VI - Members Rights to Continue Business:

The right, if given, of the remaining members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall be:

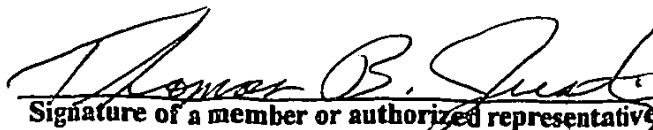
Each of the two principal members is given the right to continue the business, given the death of the other.
