**ARTICLES OF ORGANIZATION  
OF

The undersigned subscriber to these Articles of Organization, desiring to form a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, and being a natural person competent to contract, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a limited liability company under the laws of the State of Florida.

**ARTICLE I (NAME)**

The name of this limited liability company shall be K. J. Schnor Enterprises, L.C. ("the Company").

**ARTICLE II (DURATION)**

The Company shall have perpetual existence, beginning on the date these Articles of Organization are filed in the Office of the Secretary of State of the State of Florida.

**ARTICLE III (PURPOSE)**

The Company is organized for the purpose of transacting any and all lawful business, both within and without the State of Florida, and it shall have all powers allowable to it under the laws of the State of Florida, as now or hereafter conferred. Without limiting the Company's powers and authority, the Company shall have full power and authority to do all and everything necessary or proper for the accomplishment of the objects and purposes of the Company, as determined by the Company's members in their discretion and consistent with the laws of the State of Florida, or as necessary or incidental to the protection and benefit of the Company, and in general to carry out any

lawful business, regardless of whether such business is similar in nature to the objects set forth herein, and in any part of, the world, either as principal, agent, contractor, or otherwise, and either alone or in conjunction with any persons, firm associations, corporations, or other entities, both within and without the State of Florida, to the same extent as natural persons lawfully might or could do, insofar as acts may be permitted to be done by a limited liability company organized under the laws of the State of Florida.

#### **ARTICLE IV (PRINCIPAL OFFICE)**

The mailing address and the street address of the Company's principal office shall be 56 S. Alcaniz, Pensacola, FL 32501, or such other place or places as the members from time to time may determine. The name of the initial registered agent of the Company shall be Gary W. Huston and the street address of the initial registered agent is 3 West Garden Street, Suite 600, Pensacola, Florida 32501.

#### **ARTICLE V (CAPITAL CONTRIBUTIONS)**

The initial amount of capital contributions (including cash and a description of the agreed value of property) to the Company will be no more than Ten Thousand Dollars (\$10,000.00), which will be contributed by the members.

#### **ARTICLE VI (MANAGEMENT)**

The Company is to be managed by one or more managers. Until the first annual meeting of members or until the initial manager's successor is elected and qualified, the manager's name and address are:

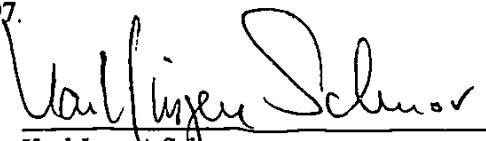
**ARTICLE VII (ADMISSION OF MEMBERS)**

**ARTICLE VIII (CONTINUATION)**

The remaining members of the Company may in accordance with the requirements specified in the Company's Operating Agreement, continue the business of the Company in the event of the termination of membership of a member in the Company (by reason of death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event terminating membership in the Company).

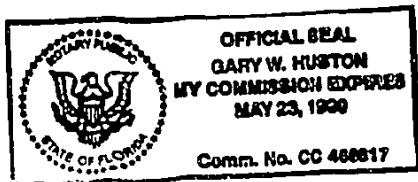

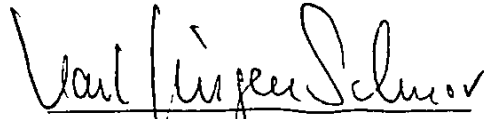

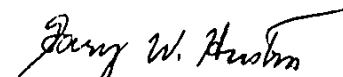
