ARTICLE I

The name of the limited liability company is: London Ventures, L.C.

ARTICLE II

The duration of the limited liability company is perpetual.

ARTICLE III

ARTICLE IV

ARTICLE VII

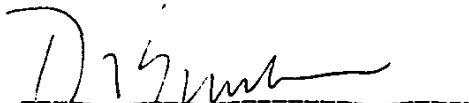

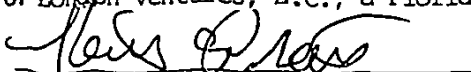
