ARTICLE V - Admission of Additional Members:

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:

Additional members may be admitted by unanimous consent of all members, under terms and conditions agreed to, in writing, by them. The necessary Certificate of Amendment shall be filed with the Florida Department of State, should an additional member be admitted.

An assignment of a member's interest may be made only with the unanimous consent of the other members. A member shall cease to be a member upon assignment of his or her entire membership interest. An assignee of an interest in the limited company may become a member only if the other members unanimously consent.

In no event shall shares of the limited company be traded publicly.

Upon the occurrence of an event which terminates the continued membership of a member, the remaining members shall have the right to continue the limited company, so long as they unanimously agree to do so.
