ARTICLES OF ORGANIZATION  
COLUMBUS INVESTMENT & DEVELOPMENT, L.C.

The undersigned, desiring to form a limited liability company (the "Company") pursuant to the Florida Limited Liability Company Act, hereby make and declare these Articles of Organization.

Article I - Name

The name of the Company is COLUMBUS INVESTMENT & DEVELOPMENT, L.C.

Article II - Duration and Commencement

This Company shall commence on the date these Articles are filed with the Department of State, and the duration of the Company shall continue thereafter for a period of 30 years unless the Company is sooner dissolved by unanimous vote of its members.

Article III - Mailing Address and Principal Office

The mailing address of the Company is 1506 Jewel Box Ave., Naples, Florida 34102, and the street address of the principal office of the Company is 1506 Jewel Box Ave., Naples, Florida 34102.

Article IV - Initial Registered Office and Agent

The name and street address of the initial registered agent of this Company is John Patterson, 46 North Washington Boulevard, Suite 1, Sarasota, FL, 34236.

Article V - Voting by Members and Managers

All members of the Company shall be entitled to vote on matters relating to the Company. The number of votes a member shall have shall be determined by the member's proportionate share in the contributions to the capital of the Company.

Article VI - Membership

Additional members may be admitted to the Company with the consent of members holding at least two-thirds interest in the Company if permitted by law and upon such terms as may be agreed upon by such members.

A member's interest in the Company may not be transferred or assigned except with the prior written consent of members having a majority interest in the Company.

Article VII - Continuance of Company

The remaining members shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member at the election of those members who then have a majority interest in the Company.

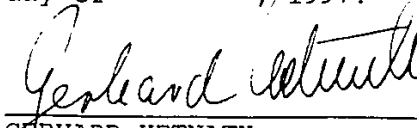
Article VIII - Management
