**ARTICLES OF AMENDMENT OF THE
ARTICLES OF ORGANIZATION OF
L. W. INVESTMENTS, L.C.**

The following provision of the Articles of Organization of L. W. Investments, L.C., a Florida limited liability company ("LLC"), Document Number L97000000309 be, and it is hereby, amended as shown below:

Paragraph 8, the Articles of Organization this limited liability company is amended to read in its entirety as follows:

8. **Capitalization.** The capital contribution of the Members, having an agreed value totaling \$ 1,300,000.00, when contributed, shall consist of real property located within the State of Florida, and shall be allocated as follows:

L. W. Holdings, LDC - \$1,287,000 (99%) Leopold Wieninger -\$13,000 (1%)

The foregoing amendment was approved by all of the members of this LLC as of even date herewith, and shall be effective as of the 12th day of March, 1997.
