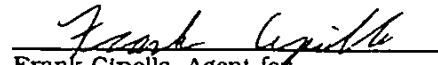

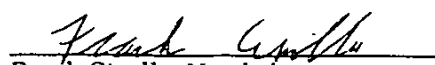
That after review of its filed Articles of Limited Liability find an erroneous statement that needs to be corrected and therefore:

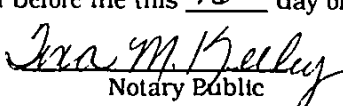
