

## **Articles Of Organization Of Hue Hue Tenango of Florida, L.L.C.**

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.401 to 608.471, do hereby adopt the following Articles Of Organization for the Limited Liability Company:

### **FIRST**

The name of the Limited Liability Company is: HUE HUE TENANGO OF FLORIDA, L.L.C.

### **SECOND**

The latest date on which the Limited Liability Company is to dissolve is thirty years from the date of filing of the Articles of Organization.

### **THIRD**

The Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Florida Statutes Annotated Sections 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

No additional capital contributions have been agreed to by the Members at this time.

The existing Members shall have the right to admit additional Members to the Limited Liability Company, by the unanimous vote or consent of the Members, in accordance with the terms and conditions of the Operating Agreement of the Limited Liability Company.

None of the Members of the Limited Liability Company are liable for payment of any debt, obligation or other liability of the Limited Liability Company.

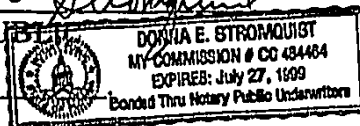
