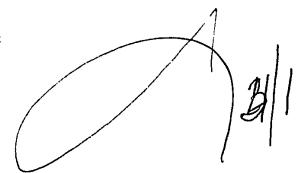

ARTICLES OF ORGANIZATION OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Additions. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I - NAME

ARTICLE VII - ADMISSION OF NEW MEMBERS
