THIRD: The following amendment to the Articles of organization was adopted by the Limited Liability Company:

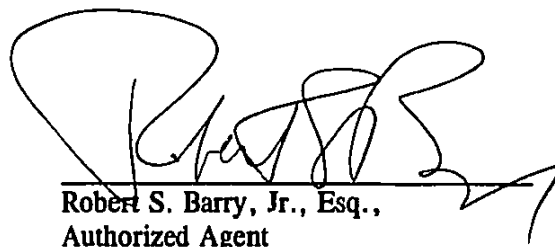
