

ARTICLES OF ORGANIZATION

COUNTY OF MANATEE

BE IT KNOWN, that on this 315r day of January, 1997;

BEFORE ME, a Notary Public, duly commissioned and qualified in and for the indicated State and County, and in the presence of the undersigned witnesses, personally came and appeared the undersigned, who, acting as organizer of a limited liability company under the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such limited liability company:

ARTICLE I NAME

The name of the limited liability company is Manatee County Physician Organization, L.L.C.

ARTICLE II

INITAL PRINCIPAL ADDRESS

The address of the initial principal office of the limited liability company is 6100 Pointe West Blvd., Bradenton, Florida, 34209.

ARTICLE III INITIAL REGISTERED AGENT

The name of the limited liability company's initial registered agent is Todd Batey. The address of the initial registered agent is 6100 Pointe West Blvd., Bradenton, Florida, 34209.

ARTICLE IV DURATION

The period of duration of the limited liability company is thirty (30) years from the date of the initial filing with the Department of State.

ARTICLE V PURPOSE

The purpose for which the limited liability company is organized is the establishment of contractual agreements between its members and managed care entities, insurance companies, employers and/or other persons and the transaction of any or all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act.

ARTICLE VI MANAGEMENT

The limited liability company is to be managed by a manager or managers. Each initial manager will hold office for a term of three years. Thereafter, the terms shall be staggered as determined by the managers. The names, municipal addresses and initial terms of the initial managers are as follows:

ARTICLE VII INDEMNIFICATION

The limited liability company shall indemnify any person who was, is or is threatened to be made a named defendant or respondent in a proceeding (as hereinafter defined) because the person (a) is or was a manager or officer of the limited liability company or (b) while a manager or officer of the limited liability company, is or was serving at the request of the limited liability company as a director, manager, officer, partner, venturer, proprietor, trustee, employee, agent, or similar functionary of another foreign or domestic corporation, partnership, limited liability company, joint venture, sole proprietorship, trust, employee benefit plan, or other enterprise, to the fullest extent that a limited liability company may grant indemnification to a person serving in such capacity under the Florida Limited Liability Company Act, as the same exists or may hereafter be amended.

Such right shall be a contract right and shall include the right to be paid by the limited liability company for all expenses incurred in defending any such proceeding in advance of its final disposition to the maximum extent permitted under the Florida Limited Liability Company Act, as the same exists or may hereafter be amended. If a claim for indemnification or advancement of expenses hereunder is not paid in full by the limited liability company within 90 days after a written claim has been received by the limited liability company, the claimant may at any time thereafter bring suit against the limited liability company to recover the unpaid amount of the claim, and if successful in whole or in part, the claimant shall be entitled to be paid also the expenses of prosecuting such claim. It shall be a defense to any such action that such indemnification or advancement of costs of defense are not permitted under the Florida Limited Liability Company Act, but the burden of proving such defense shall be on the limited liability company. Neither the failure of the limited liability company (including its managers or any committee thereof, special legal counsel, or members) to have made its determination prior to the commencement of such action that indemnification of, or advancement of costs of defense to, the claimant is permissible in the circumstances nor an actual determination by the limited liability company (including its managers or any committee thereof, special legal counsel, or members) that such indemnification or advancement is not permissible, shall be a defense to the action or create a presumption that such indemnification or advancement is not permissible.

As used herein, the term "proceeding" means any threatened, pending, or completed action, suit, or proceeding, whether civil, criminal, administrative, arbitrative, or investigative, any appeal in such an action, suit, or proceeding, and any inquiry or investigation that could lead to such an action, suit, or proceeding.

ARTICLE VIII LIMITED LIABILITY

A manager of the limited liability company shall not be liable to the limited liability company or its members for monetary damages for the breach of any duty provided in Section 608.422 of the Florida Limited Liability Company Act in the manager's management capacity, except that this Article VIII does not eliminate or limit the liability of a manager for the amount of a financial benefit received by a manager to which such manager is not entitled, or for an intentional violation of criminal law or an intentional infliction of harm on the limited liability company or the members, or for a violation of the Florida Limited Liability Company Act.

Neither the amendment nor repeal of this Article VIII, nor the adoption of any provision of these Articles of Organization inconsistent with these Articles, shall eliminate or reduce the effect of these Articles in respect of any matter occurring, or any cause of action, suit, or claim that, but for these Articles, would accrue or arise, prior to such amendment, repeal, or adoption of any inconsistent provision. If the Florida Limited Liability Company Act or any successor act thereto is amended to authorize action by a limited liability company further eliminating or limiting the personal liability of managers, then the liability of a manager of the limited liability company shall be eliminated or limited to the fullest extent permitted by the Florida Limited Liability Company Act or any successor act thereto, as so amended from time to time.

ARTICLE IX DISSOLUTION

Upon the death, retirement, expulsion, bankruptcy or dissolution of any member, or upon the occurrence of any other event that terminates the continued membership in the limited liability company of any member, if there shall be at least two members remaining, the limited liability company shall not be dissolved, and the business of the limited liability company shall be continued if within 90 days of such event members representing a majority of all member votes (excluding the votes represented by the member or members causing the dissolution) and members representing a majority of the capital account balances owned by all of the members (excluding the capital account balances owned by the member or members causing the dissolution) so agree.
