ARTICLES OF ORGANIZATION OF RESORT MANAGEMENT SERVICES -- CRYSTAL BEACH L.C

The undersigned hereby certify that we have associated ourselves together for the purposes of becoming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liabilities companies for profit. I further declare that the following articles shall be the charter and authority of the conduct of business of such limited liability company.

ARTICLE I

NAME

PROFITS AND LOSSES

- (a) Sharing of Profits.
