The undersigned, being a natural people of at least 18 years of age and acting as the Organizer of the Limited Liability Company hereby being formed under the Florida Statutes, Chapter 608, does hereby adopt the following Organization for the Limited Liability Company:

ARTICLE I

The name of the Limited Liability Company is Taylor Built Homes, L.C.

ARTICLE II

The latest date on which the Limited Liability Company is to dissolve is December 31, 2016.

ARTICLE III

The Limited Liability Company is organized to operate a home construction business and to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with the Florida Statutes, including all powers and purposes now and hereafter permitted by law to a limited liability company.

ARTICLE IV
