We, the undersigned natural persons competent to contract, hereby organize and form a limited liability company ("the Company") under and pursuant to Chapter 608, Florida Statutes as follows:

ARTICLE 1.

Name of Limited Liability Company

The name of the Company shall be WELP Commons, L.C.

ARTICLE 2.

Period of Duration

The existence of the Company shall be continuous from the date of filing these Articles with the Department of State until thirty-five (35) years thereafter.

ARTICLE 3.

Purpose

The Company is organized for the purpose of becoming the general partner of a limited partnership ("the Partnership") formed or to be formed to acquire a Shopping Center in Memphis, Tennessee ("the Property") and for the purpose of transacting any and all lawful business in connection therewith which limited liability companies may transact pursuant to Chapter 608, Florida Statutes.

ARTICLE 4.

Place of Business and Registered Agent
