These Articles of Organization are made for the pupped of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes.

SECTION 1

NAME

The name of this limited liability company is Collier Neurologic Specialists, L.C. (the "Company").
