CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION OF COLLIER NEUROLOGIC SPECIALISTS, L.C.

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, the undersigned, who are all the members of COLLIER NEUROLOGIC SPECIALISTS, L.C., amend the Articles of Organization of the limited liability company originally filed with the Secretary of State of Florida on May 29, 1997, as follows:

1. Section 1 of the Articles of Organization is hereby revoked, and the following new Section 1 is inserted in lieu thereof:

"SECTION 1 NAME

The name of this limited liability company is Collier Neurologic Specialists, P.L. (the 'Company')."

2. Section 6 of the Articles of Organization is hereby revoked, and the following new Section 6 is inserted in lieu thereof:

"SECTION 6

TERMINATION OF MEMBERSHIP

Upon the death, bankruptcy, or dissolution of a member, or upon the occurrence of any other event that terminates the continued membership of a member in the Company as set forth in the Regulations of the Company or in Florida Statutes Chapter 608, the business of the Company shall continue unless the remaining member(s), by Majority Vote, elect to discontinue the business."

3. The following new Section 11 is hereby added to the Articles of Organization:

"SECTION 11 PURPOSES OF THE COMPANY

The purposes of this limited liability company are to engage in the practice of medicine; to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of professional medical services; and to do everything necessary, proper, or convenient to accomplish the purposes set forth in these Articles, and to do every other act incidental to the company's purposes which is not forbidden by Florida laws or by the provisions of these Articles."

The members of COLLIER NEUROLOGIC SPECIALISTS, L.C. have executed the preceding amendment to the Articles of Organization of the company on $\leq e_{2}$, 24, 1999.
