**CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

We, the undersigned, representing all of the members of Greater Bay Auto Auction, L.C., pursuant to Section 608.411, Florida Statutes, hereby submit for filing to the Department of State of Florida this Certificate of Amendment to the Articles of Organization for Greater Bay Auto Auction, L.C., and state:

1. The name of the Limited Liability Company is Greater Bay Auto Auction, L.C.
2. The Articles of Organization of Greater Bay Auto Auction, L.C., were filed on June 23, 1997, with the Department of State of Florida.

**ARTICLE V

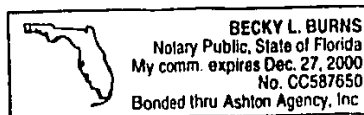

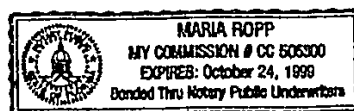
