ARTICLES OF ORGANIZATION

OF

V.SHIPS FLORIDA L. C.

ARTICLE I

The name of this Limited Liability Company shall be: V.Ships Florida L. C.

ARTICLE II

This Limited Liability Company shall exist for a period of thirty (30) years from the date of filing the Articles of Organization with the Florida Secretary of State, unless sooner dissolved by the Members or as provided by statute.

ARTICLE III

This Limited Liability Company is created for the purpose of transacting any legal and lawful business pursuant to the Florida Limited Liability Company Act.

ARTICLE IV

The place of business and the mailing address of this Limited Liability Company shall be 100 S. E. Second Street, Suite 2930, Miami, Florida 33131 or such other place or places as the Members from time to time may determine.

ARTICLE V

The initial amount of capital contributions (including cash and a description of the agreed fair market value of property) is \$450,000, which will be contributed by the Members. Additional contributions will be made at such times and in such amounts as may be agreed by the Members.

ARTICLE VI

The Limited Liability Company will be managed by a Board of Managers. The members of the initial Board of Managers shall serve as managers until the first annual meeting of Members or until their successors are elected and qualify. ARTICLE VII

The Members reserve the right to admit additional Members on the unanimous agreement of the Members as to the admission of, the consideration to be paid by, and the rights and privileges of such new Members, and subject to the terms and conditions of the Limited Liability Company's Regulations.

ARTICLE VIII

The Members shall have the right to continue the Limited Liability Company and its name and its business notwithstanding the death, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Limited Liability Company provided that either a) all the remaining Members consent in writing thereto, or b) at least two remaining Members consent in writing thereto, which consents, in either case, shall be obtained within 90 days after the death, bankruptcy, or dissolution of a Member or the occurrence of the event which terminates the continued membership of a Member in the Limited Liability Company.

ARTICLE IX

Except as provided in the Regulations, a Member's interest in the Limited Liability Company is not subject to transfer or assignment.

ARTICLE X

These Articles may be amended only by a unanimous vote of the Members.

ARTICLE XII

The street address of the Limited Liability Company's initial registered office is 100 S.E. 2nd Street, Seventeenth Floor, Miami, Florida 33131. The name of the initial registered agent at such office is Donald E. Kubit.

The initial noncash contributions of the members are to be as follows:
