ARTICLES OF ORGANIZATION

ARTICLE I - NAME

The name of this limited liability company is COUNTRY TIME DAY STAY, L.C.

ARTICLE II - PURPOSE

The general nature of the business to be transacted by the limited liability company shall be to operate and maintain an adult day health care center; and to have and exercise all of the powers now or hereafter conferred by the laws of the State of Florida upon limited liability companies organized pursuant to the laws under which this limited liability company is organized and any and acts, amendatory thereof and supplemental thereto.

ARTICLE III - DURATION

The period of this limited liability company's duration shall be a period not to exceed thirty (30) years from July 1, 1997, or the date of filing of these Articles of Organization with the Florida Department of State, whichever is later.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

The initial address of this limited liability company's place of business is 837 East Parker Street, Lakeland, Florida, 33801 and the name and address of the initial registered agent of this limited liability company at that address is MARTHA J. SOMMARS. The mailing address of the limited liability company and its registered office is the same as above.

#### ARTICLE VI - CONTRIBUTION

The total amount of cash or property to be initially contributed to the limited liability company is \$1,500.00. No other property shall be initially contributed. The members have agreed to make any additional contributions in accordance with the regulations to be adopted by the limited liability company from time to time.

#### ARTICLE VII

The members of the limited liability company shall have the right to admit additional members by unanimous vote of all current members to be effective upon such prospective members agreeing in writing to assume any obligations of a member which may be set forth in the regulations adopted by the limited liability company from time to time.

#### ARTICLE VIII - CONTINUATION OF BUSINESS

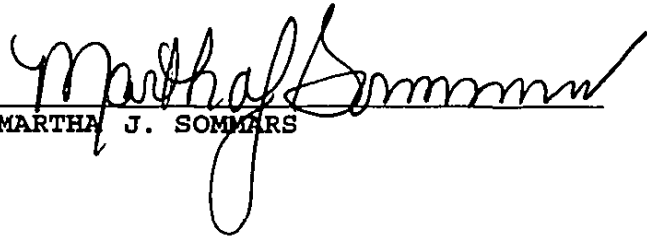

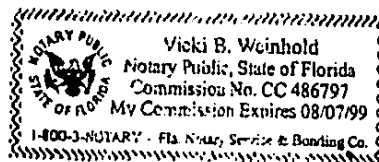
