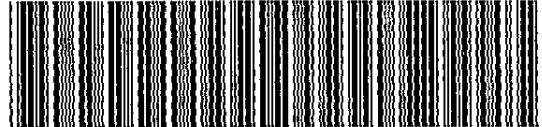

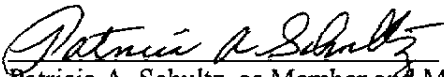

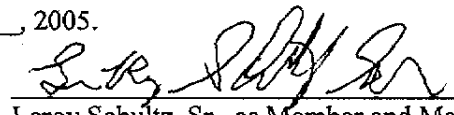
**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
(TO CHANGE NAME OF BEN'S HITCHING POST CAMPGROUND, L.C.
TO SCHULTZ HOLDING, L.C.)**
