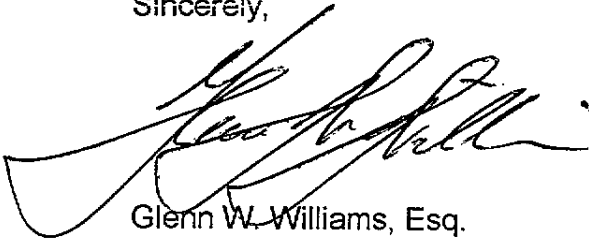

ADDRESS OF OFFICE AND AGENT

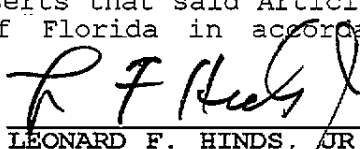
