**ARTICLE I  
NAME**

The name of this limited liability company shall be:

**ARTICLE II  
ADDRESSES**

**ARTICLE III  
DURATION**

The existence of this limited liability company shall begin upon the filing of these Articles of Organization and shall continue in perpetuity, unless terminated as provided for in the regulations of this limited liability company or by general law.

**ARTICLE IV  
PURPOSE OF THE LIMITED LIABILITY COMPANY**

***ARTICLE X***  
**AMENDMENT OF ARTICLES OF ORGANIZATION**

The power to adopt, alter, amend or restate these Articles of Organization is vested in the members. Any adoption, alteration, amendment or restatement of these Articles of Organization must be approved by a majority of the members.

***ARTICLE XI***  
**AMENDMENT OF REGULATIONS**

The power to adopt, alter, amend or repeal the regulations of this limited liability

company is vested in the committee of managing members. Any adoption, alteration, amendment or repeal of the regulations shall require a majority vote of the managing members.

**ARTICLE XII**  
**REGISTERED AGENT AND REGISTERED OFFICE**

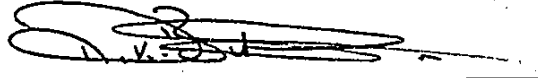
