### ARTICLE I NAME

The name of this Limited Liability Company is GLOBAL MUSIC NETWORK TAMPA, L.C.

#### ARTICLE V ADDITIONAL MEMBERS

No right is granted herein to admit additional members to this Limited Liability Company unless a member shall die, retire, resign, be involuntarily removed, declare bankruptcy, or be dissolved. Any new member must be financially qualified, with a minimum net worth of one million dollars (\$1,000,000.00), and must invest a minimum of ten thousand dollars (\$10,000.00).

### ARTICLE VI CONTINUATION OF BUSINESS AFTER DEATH OR TERMINATION OF CONTINUED MEMBERSHIP OF MEMBER

Upon death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in this Limited Liability Company, the remaining members hereto shall have the right to continue the business of the Limited Liability Company.

### ARTICLE VII MANAGEMENT OF LIMITED LIABILITY COMPANY
