ARTICLE V-Admission of additional members:


The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:
The members of PRIMARY CARE PHYSICIANS, P.L. are given and have the right to admit additional members if, and only if, such a person is a professional corporation, a professional limited liability company, or an individual, each of which must be duly licensed or, otherwise, legally authorized to render the same specific professional services as those for which PRIMARY CARE PHYSICIANS, P.L. is organized. Said person also shall comply with the terms and conditions established in the Operating Agreement of PRIMARY CARE PHYSICIANS, P.L.. Otherwise, such a person must not be admitted as member.

ARTICLE VI-Members rights to continue business:

The right, if given, of the remaining members of PRIMARY CARE PHYSICIANS, P.L. to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in PRIMARY CARE PHYSICIANS, P.L. shall be:

The remaining members are given and have the right to continue business upon the occurrence of the events above described; however, no person shall be admitted as a member of PRIMARY CARE PHYSICIANS, P.L. unless such a person is a professional corporation, a professional limited liability company, or an individual each of which must be duly licensed or otherwise, legally authorized to render the same specific professional services as those for which PRIMARY CARE PHYSICIANS, P.L. is organized.

No member of PRIMARY CARE PHYSICIANS, P.L. shall enter into any type of agreement vesting another person with the authority to exercise any of that member's voting power in PRIMARY CARE PHYSICIANS, P.L..
