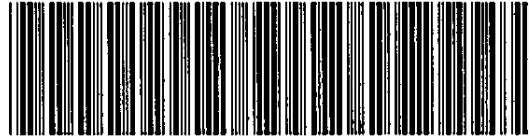




Agreement between BE Pressure (SE USA), LLC & Curt, Inc
