Bernstein, M.D., natural persons competent to contract, hereby present these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapter 621, Florida Statute.

ARTICLE I - NAME

The name of the professional limited liability company is:

ARTICLE II - PRINCIPAL OFFICE ADDRESS
