# **ARTICLES OF ORGANIZATION OF FUN SCIENCE, L.C.**

## **ARTICLE I**

### **Name**

The name of the limited liability company ("Company") is Fun Science, L.C.

## **ARTICLE II**

### **Address**

**Admission of New Members**

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

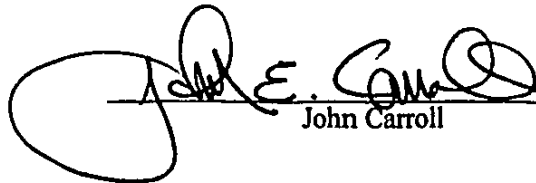
**ARTICLE VII**

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. **ARTICLE VIII**  
**Additional Provisions**

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managers listed in Article V.

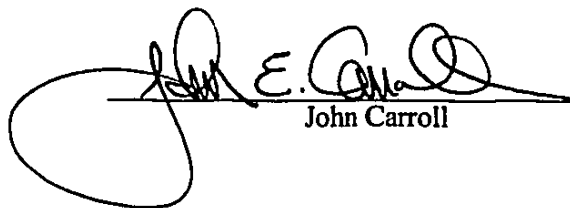

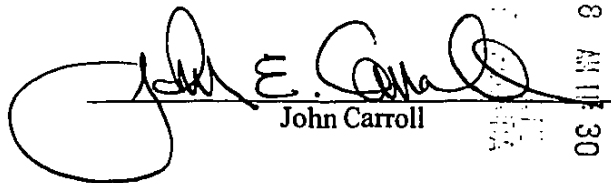
