# ARTICLES OF DISSOLUTION

THE UNDERSIGNED, being a 59% (fifty nine percent) capital interest holder of ALPHA FIFTEEN LIMITED COMPANY ("Company") hereby files this, its Articles of Dissolution pursuant to F.S. 608.455 and states:

1. The name of the limited liability company is ALPHA FIFTEEN LIMITED COMPANY.

2. The effective date of the limited liability company's dissolution is August 31, 1998.

3. A description of the occurrence that resulted in the Company's dissolution is as follows: The continued membership of Professional Rehab Inc. in the Company has been terminated as Professional Rehab, Inc. has resigned its membership from the Company. The Company may be dissolved by a majority vote of the capital interest of the Company pursuant to Article VI of the Articles of Organization of the Company.

4. All debts, obligations, and liabilities of the company have been paid or discharged, or adequate provision has been made therefore pursuant to F. S. 608.441.

5. All remaining property and assets have been distributed among its members in accordance with their respective rights and interests.

6. There are no suits pending against the Company in any Court.
