ARTICLES OF ORGANIZATION

The undersigned acting as organizer of ENGELMAIER ASSOCIATES, L.C., under the Florida Limited Liability Company Act, adopt the following Articles of Organization for said limited liability company.

ARTICLE I
NAME

The name of the limited liability company shall be **ENGELMAIER ASSOCIATES, L.C.**, (the "LLC").

ARTICLE II

DURATION

This LLC shall exist perpetually, unless dissolved according to law or as set forth in the LLC's Operating Agreement.

ARTICLE III

PURPOSE

The LLC is to be managed by a Manager or Managers. The name and address of the Initial Manager of the LLC who shall serve as Manager until a successor is elected and qualified is:

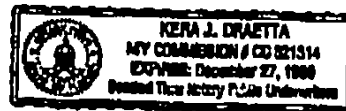
