**ARTICLES OF ORGANIZATION
CAPOBIANCO ENTERPRISES, L.C.**

The undersigned, desiring to form a limited liability company ("Company") pursuant to the Florida Limited Liability Company Act, hereby makes and declares these Articles of Organization.

Article I - Name

The name of the Company is CAPOBIANCO ENTERPRISES, L.C.

Article II - Duration and Commencement

Article III - Purpose


Article VIII - Management

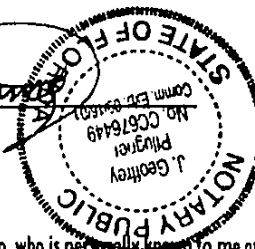

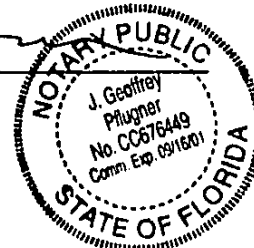
