ARTICLES OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION
OF

The name of this Organization is: EFFECTIVE RECRUITING.COM, L.C.

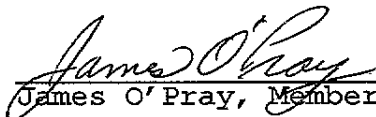
ARTICLE II of the Articles of Incorporation is hereby amended in its entirety to read as follows:
