ARTICLES OF ORGANIZATION  
OF  
**SANITARY COATING SYSTEMS, L.C.**  
a Florida Limited Liability Company

The undersigned, desiring to form a Limited Liability Company pursuant to Florida Statutes Chapter 608 hereby state as follows:

ARTICLE I

The name of this Limited Liability Company shall be **SANITARY COATING SYSTEMS, L.C.**

ARTICLE II

The duration of this Company shall commence when these Articles of Organization are filed with the Secretary of State of the State of Florida until thirty (30) years thereafter, unless earlier dissolved by agreement of the Members hereof, or by operation of law.

ARTICLE III

The purpose for which this Company is organized is to distribute at the wholesale and retail level and manufacture specialized paint and coating products in the United States, or such other lawful businesses as the Members may agree from time to time.

ARTICLE IV

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of any Member hereof, the remaining Members shall have the right pursuant to Regulations adopted by said Members to continue the existence of this Company.

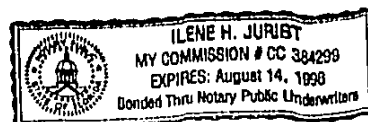


