# ARTICLES OF ORGANIZATION OF WORLDWIDE FILTER COMPANY, L.C.

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

## **ARTICLE I - NAME**

The name of the limited liability company shall be WORLDWIDE FILTER COMPANY, L.C. ("Company").

# **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the company shall be 70 Station Street, Oviedo, Florida 32765.
