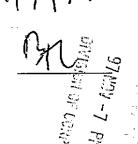

#### ARTICLES OF ORGANIZATION

OF

## PC PROPERTIES, L.C.

COME NOW, the undersigned hereby and state the following Article of Organization of PC PROPERTIES, L.C., as follows:

## ARTICLE I

#### NAME

A. The name of the limited liability company shall be PC PROPERTIES, L.C., but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

## ARTICLE II

#### DURATION

B. The duration of the limited liability company shall be perpetual, or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

#### ARTICLE IV

#### MANAGEMENT

## ARTICLE VI

## RESTRICTIONS ON MEMBERSHIP

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all members.

This article may be amended from time to time in the regulations of the limited liability company by a unanimous vote of the members of the limited liability company.
