Pursuant to the provisions of Section 608.407 Florida Limited Liability Company Act, the undersigned organizer submits these articles of organization for the purpose of organizing a Limited Liability Company.

ARTICLE I - **Name.** The name of the Limited Liability Company is

ARTICLE II - **Address.** The mailing address and street address of the principal executive office of the Limited Liability Company is 778 Jimmy Ann Drive, Daytona Beach, Florida.

ARTICLE III - **Duration.** The duration of the Limited Liability Company shall end on December 31, 2050.

ARTICLE IV - **Management.** The Limited Liability Company is to be managed by the members and the name and address of the managing member is Nathan C. Stophel, 778 Jimmy Ann Drive, Daytona Beach, Florida 32114.

ARTICLE VIII - **Preemptive Rights.** The members shall not have preemptive rights.
