

CERTIFICATE OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF K.A. AVENTURA, L.C.

The undersigned members of K.A. Aventura, L.C. hereby amend the Articles of Organization of such limited liability company as follows:

- A. The name of the limited liability company is K.A. Aventura, L.C.
- B. The Articles of Organization of the company were filed on November 19, 1997.
- C. The Articles of Organization are amended as follows:

1. Article VI (Termination of Existence) is hereby deleted and substituted therefor is the following new Article VI:

The company shall not be dissolved on the death, bankruptcy or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless as a result of such event, there is only one remaining member.

2. Article VII (Management) is hereby deleted and substituted therefor is the following new Article VII:

The company shall be managed by the Managers in accordance with regulations adopted by the Members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation of management of the affairs of the company not inconsistent with law or these Articles of Organization. 
