Article VI. Dissolution

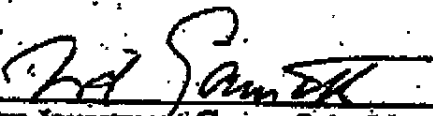

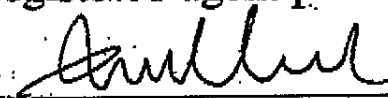
