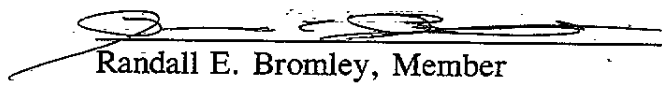
The members are authorized to admit additional members to the Company in the manner set forth in the Company's Operating Agreement.

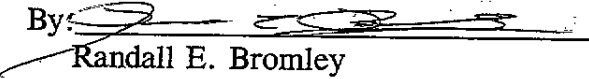
