**AMENDMENT TO ARTICLES OF ORGANIZATION
OF
ACCESS MEDICAL SOUTH, L.C.**

The Articles of Organization of Access Medical South, L.C. are amended as follows:

1. Article II should now read as follows:

"Said limited liability company is organized to provide durable medical equipment, oxygen and respiratory services to patients in Charlotte, DeSoto, Hardee, Lee, Manatee and Sarasota Counties, Florida and to engage in the delivery of health care services to the public and other organizations."

The duration of this limited liability company shall continue until the limited liability company is terminated pursuant to the provisions of the Regulations of Access Medical South, L.C.

2. Article IV shall now read:

"The Members of this Company are Lee Memorial Home Health, Inc. and Morton Plant Hospital Association, Inc."

3. Article VII shall now read as follows:

"The business of this Limited Liability Company shall be conducted, carried on, and managed by a management committee acting pursuant to Chapter 608, Florida Statutes. 

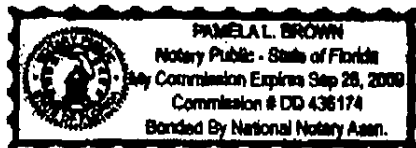
