ARTICLE I
NAME

The name of this Limited Liability Company shall be REX QUALITY DEVELOPMENT, L.C.

ARTICLE II
DURATION

This Limited Liability Company shall exist for a period of Thirty (30) years from the date of filing with the Secretary of State of the State of Florida.

ARTICLE III
PURPOSE

This Limited Liability Company is organized for the purpose of conducting all lawful business, including but not limited to, planning, developing, and building residential and commercial developments in Central Florida.

ARTICLE VI
CAPITAL CONTRIBUTION

The initial amount of cash capital contributions is \$51,306.00, and the anticipated cash capital contributions are \$1,861,466.00, which will be contributed by the members.

ARTICLE VII
MANAGEMENT

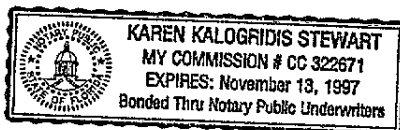
