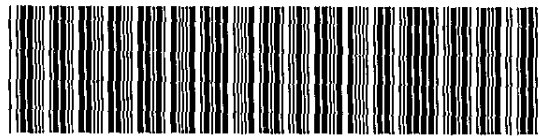

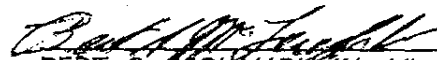

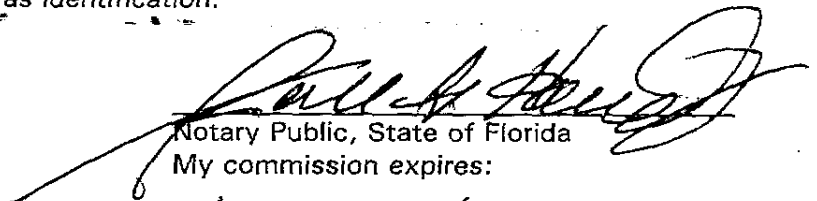
1. The name of the corporation is ACCMO ELECTRICAL SERVICE, INC. (the "corporation").
