1. **Name.** The name of the limited liability company is Windrider, L.L.C.
2. **Duration.** The period of duration of the limited liability company is perpetual.

5. **Additional Members.** The right of the Members to admit additional Members and the terms and conditions of the admissions are:

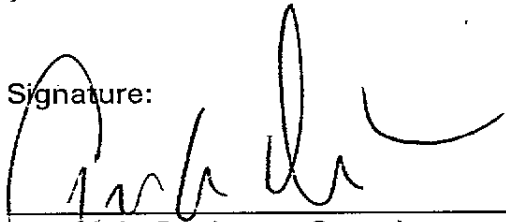

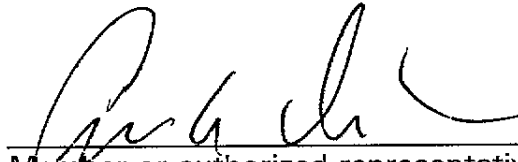
