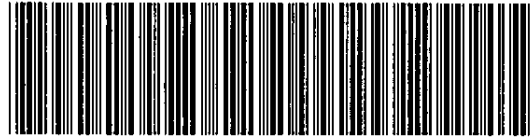

ARTICLE I — Name:
