The undersigned adopts the following Articles of Organization for the purpose of becoming a Limited Liability Company under the Florida Limited Liability Company Act.

1. Name. The name of the limited liability company referred to in these Articles as "Company," is:

BEN'S PAINT SUPPLY, L.C.

2. Duration. The Company shall dissolve on December 31, 2020.

3. Purpose. The purpose for which Company is organized is to transact any or all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act.

4. Addresses. The mailing address and the street address of the principal office of the Company shall be:

Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time new members are admitted.
