The undersigned members adopt the following Articles of Organization to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I

NAME

The name of the limited liability company is **INTEGRATED DATA SOLUTIONS ASSOCIATES, L.L.C.** (the "Company").

ARTICLE II

PERIOD OF DURATION

The term for which the Company is to exist shall commence on the date these Articles of Origination are filed in the Office of the Florida Department of State, and shall continue until December 31, 2026; provided, however, that the Company shall be dissolved prior to such date (a) upon the written consent of all the members, (b) as provided in the Operating Agreement, or (c) as may be required by the Act.

DISSOLUTION AND RIGHT TO

The Company shall be dissolved upon the first to occur of the following:

- (c) The death, retirement, resignation, expulsion, dissolution or bankruptcy of a member, or any other event which terminates the membership of a member in the Company, unless within ninety (90) days after such event all all of the remaining members agree in writing to continue the business of the Company.
