ARTICLES OF ORGANIZATION OF INTEGRATED DATA SOLUTIONS ASSOCIATES, L.L.C.

The undersigned members adopt the following Articles of Organization to the provisions of the Florida Limited Liability Company Act (the "Act").

ARTICLE I

NAME

The name of the limited liability company is INTEGRATED DATA SOLUTIONS ASSOCIATES, L.L.C. (the "Company").

ARTICLE II

PERIOD OF DURATION

DISSOLUTION AND RIGHT TO

The Company shall be dissolved upon the first to occur of the following:
