ARTICLES OF ORGANIZATION OF DOUDNA PROPERTIES, L.C.

The undersigned hereby certify that we have associated ourselves together for the purposes of becoming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liabilities companies for profit. PROFITS AND LOSSES

(a) Sharing of Profits. The members shall be entitled by SECRET CONTROL OF THE CO

(b) Losses.
