**ARTICLE I. - NAME**

The name of this limited liability company is NETMARK REPREENEUR FORCE, L.C.

**ARTICLE II. - DURATION**

Unless dissolved earlier according to law, this limited liability company shall exist for a period of ten (10) years commencing on the date of filing these Articles of Organization with the Department of State of the State of Florida.
